#### 6. Activities and Project Updates:

### a. Avila Beach Public Art Project

- The Selection Panel has recommended a winning project that is on PSL property
- Prior to making public announcement the winning project is being presented to the PSL Property Committee on April 20<sup>th</sup> and entire PSL Harbor Commission on April 26<sup>th</sup>
- If approved then Foundation will make a public announcement
- Arts Obispo is drafting contract with the artist and contract between the Foundation & Arts Obispo that outlines the financial arrangement for paying the artist
- o Overall a good process and optimistic that project will be approved

### b. Internet Safety & Best Practices Workshop

- Approximately 30-35 people attended the Workshop that was held Feb. 25
- Special thanks to board member Gary Maier and his colleague Dennis Royer for presenting workshop
- Excellent feedback on the workshop from the participants

## 7. Foundation Reporting, Planning and Action Items:

a. Rick C. provided a breakdown of the Deferred Expenses Ledger Holdings Summary accounts totaling \$57,146 of which approximately \$30,000 are non-restricted 100% discretionary funds that can be spent by the Foundation for operational expenses as needed or charitable requests received outside of the normal grant period

- Money is held in checking account at Founders Bank in SLO and not related to UBS holdings
- Having local bank is convenient for depositing miscellaneous contributions to the Foundation
- Rick will provide an update of this account information on an annual basis

b. It was noted that the board provided email approval for a \$500 grant to AVAC and a \$750 grant to the Central Coast Aquarium in March of 2016

- Vote for the AVAC grant was: 11 yes 1 no 1 abstain
- Vote for the Central Coast Aquarium Beach Clean-up grant was: 8 yes 5 no
