opportunities. Rick explained how the Giving Circle works. Circles are composed of small groups of individuals who agree upon a specific project and have the financial resources to commit to the project.

2. Host small focus groups to explore project ideas, interests, and opportunities to those who responded affirmatively on the Avila Speaks Survey.

3. Allocate up to .25% (\$5,000 per year over three years) of portfolio to help the Community Center launch a Capital Improvements matching contributions campaign over the next three years.

4. Allocate up to .25% of the investment portfolio to launch a Giving Circle Initiative and Community Matching Gifts Initiative. Trustees agreed that the previous Community Matching Gifts Initiative was successful and we should do it again in 2015.

## Community Engagement, Outreach & Events:

1. Continue to host community engagement and educational activities such as the Town Hall Forum in early 2014 and Live Well Symposium in 2015.

**2.** Allocate up to .25% (\$5,000) of investment portfolio to hire a special events professional to organize an Avila Apples Festival or related event. Julian suggested that such an event could be part of a full weekend of activities, such as the Albacore Feed.

**3.** Hire a consultant to conduct a community "Think Tank". A professional facilitator, such as used for SLO County feedback efforts, will be able to elicit input and new project ideas from mid-size groups of 50 or more participants.

# Chris made a motion to accept the Strategic Action Plan as recently revised, Bill seconded. All approved.

## **Other Business:**

Justin has created a movie night in partnership with the SLO Film Festival and Sparky from the Avila Grocery. So far there has been a good turnout. Justin is requesting \$400 out of the Trustee Initiated Fund to purchase better sound equipment. Bill made a motion to approve the purchase as requested. Julian
